Announcement on the Information of the Issue of
2020 Tranche VI Super and Short-term Commercial Paper**

This announcement is made pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The Company and all the members of the Board of Directors confirm that all the information contained in this announcement is true, accurate and complete and that there is no false and misleading statement or material omission in this announcement.

The issue of Super and Short-term Commercial Paper (the “SCP”) of not more than RMB8 billion by ZTE Corporation (the “Company”) was registered and approved by the National Association of Financial Market Institutional Investors (中國銀行間市場交易商協會) (the “NAFMII”) pursuant to the “Notice of Admission for Registration” (Zhong Shi Xie Zhu [2019] No. SCP373) (《接受註冊通知書》(中市協注〔2019〕SCP373號)). The Company completed the issue of 2020 Tranche I to V SCP. For details, please refer to the related Announcements published by the Company on 10 October 2019, 26 March 2020, 22 April 2020 and 26 May 2020 respectively.

On 11 June 2020, the Company completed the issue of 2020 Tranche VI SCP (the “Tranche VI SCP”) at the nominal value of RMB100 each for an issue amount of RMB1 billion. The term of the Tranche VI SCP shall be 180 days and interest shall be accruable from 11 June 2020 at an interest rate of 1.63% and payable on 8 December 2020. Tranche VI SCP is lead-underwritten by China Construction Bank. Proceeds raised through Tranche VI SCP were received in full on 11 June 2020 and will be applied to repay the bank financing of the Company.
