#### **Announcement on the Fulfillment of Exercise Conditions for the Second Exercise Period, Relevant Adjustment, and Cancellation of Certain Share Options of the Reserved Grant of Share Options under the 2020 Share Option Incentive Scheme**

*This announcement is made pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.*

*The Company and all the members of the Board of Directors confirm that all the information contained in this information disclosure is true, accurate and complete and that there is no false and misleading statement or material omission in this information disclosure.*

#### **Special reminders:**

1. Exercise period: the dates on which the share options are exercisable during the period from 25 September 2023 to 22 September 2024. As it is pending to go through relevant procedures with China Securities Depository and Clearing Corporation Limited, Shenzhen Branch, the official commencement date for the second exercise period shall be separately announced.
2. Exercise price: RMB34.92 per share (namely participants shall purchase the A shares of ZTE Corporation at the price of RMB34.92 per share, which shall be financed by the participants on their own)
3. Number of exercisable share options: 2,402,000

As considered at the Fourteenth Meeting of the Ninth Session of the Board of Directors of ZTE Corporation (the "Company"), the exercise conditions for the second exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company have been fulfilled, and it is approved to make relevant adjustments to the participants and number of share options and cancel certain share options, the details of which are announced as follows:

#### **I. Brief description of the 2020 Share Option Incentive Scheme**

As considered and passed at the Twenty-fifth Meeting of the Eighth Session of the Board of Directors and the Eighteenth Meeting of the Eighth Session of the Supervisory Committee of the Company on 12 October 2020 and the Second Extraordinary General Meeting of 2020 on 6 November 2020, pursuant to the "ZTE Corporation 2020 Share Option Incentive Scheme (Draft)" (the "Draft Scheme"), a total of not more than 163,492,000 share options were granted to Directors, senior management and other key employees by the Company, of which 158,492,000 share options were granted initially, 5,000,000 share options were reserved.

As considered and passed at the Fortieth Meeting of the Eighth Session of the Board of Directors and

the Thirty-first Meeting of the Eighth Session of the Supervisory Committee of the Company on 23 September 2021, the date of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company was set for 23 September 2021 (Thursday). A total of 5,000,000 share options were granted to 410 participants with two exercise periods.

As considered and passed at the Fifth Meeting of the Ninth Session of the Board of Directors and the Fourth Meeting of the Ninth Session of the Supervisory Committee of the Company on 22 September 2022, the adjustments to participants and number of the reserved grant of share options under the 2020 Share Option Incentive Scheme, cancellation of share options previously granted to participants who no longer fulfilled the conditions to be a participant, and confirmation of the fulfillment of exercise conditions for the first exercise period of the reserved share option granted under the 2020 Share Option Incentive Scheme of the Company were approved.

As considered and passed at the Fourteenth Meeting of the Ninth Session of the Board of Directors and the Eleventh Meeting of the Ninth Session of the Supervisory Committee of the Company on 25 September 2023, the adjustments to participants and number of the reserved grant of share options under the 2020 Share Option Incentive Scheme, cancellation of share options previously granted to participants who no longer fulfilled the conditions to be a participant and the unexercised share options upon the end of the first exercise period, and confirmation of the fulfillment of exercise conditions for the second exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company, were approved.

There is no difference between the implemented share option incentive scheme and the disclosed share option incentive scheme.

## **II. Description of the adjustment of the reserved grant of share options under the 2020 Share Option Incentive Scheme and cancellation of certain share options**

### **1. Details of the adjustment of the participants and number of share options**

Before the commencement of the first exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company, the number of participants had been adjusted to 402 and the total number of share options had been adjusted to 4,909,000. For details, please refer to the “Overseas Regulatory Announcement on the Fulfillment of Exercise Conditions for the First Exercise Period, Relevant Adjustment and Cancellation of Certain Share Options of the Reserved Share Options under the 2020 Share Option Incentive Scheme” published by the Company on 22 September 2022, where the number of share options for the second exercise period is 2,454,500.

Before the commencement of the second exercise period, as 5 of the original participants have departed, they are no longer eligible as participants under the 2020 Share Option Incentive Scheme. Pursuant to the Draft Scheme, the Company shall disqualify the 5 aforesaid persons from participation in the 2020 Share Option Incentive Scheme and a total of 52,500 share options granted to them shall be withdrawn and cancelled by the Company without compensation.

Following this adjustment, the number of participants for the second exercise period of the reserved grant of share options will be adjusted from 402 to 397, and the number of exercisable share options for the second exercise period will be adjusted from 2,454,500 to 2,402,000.

### **2. Cancellation of certain share options**

(1) In view of the “1. Details of the adjustment of the participants and number of share options”, the Company shall cancel a total of 52,500 share options.

(2) As at 22 September 2023, the first exercise period of the reserved grant of share options has ended, and 323,300 share options have yet to exercise. Pursuant to the Draft Scheme, the unexercised

323,300 share options upon the end of the first exercise period shall be invalidated and cancelled by the Company without compensation.

A total of 375,800 share options shall be canceled by the Company. The Company will handle matters related to the cancellation in China Securities Depository and Clearing Corporation Limited, Shenzhen Branch. The cancellation represents normal adjustments conducted in accordance with relevant provisions under the Draft Scheme, and the cancellation will not affect the implementation of the 2020 Share Option Incentive Scheme.

Following this adjustment and cancellation, the specific data related to the reserved grant of share options under the 2020 Share Option Incentive Scheme are as follows:

### **III. Description of the fulfillment of the exercise conditions for the second exercise period of the reserved grant of share options under 2020 Share Option Incentive Scheme**

#### **(I) The second exercise period is forthcoming**

Pursuant to the Draft Scheme, the date of the reserved grant of share options under the 2020 Share Option Incentive Scheme was set for 23 September 2021. Participants may exercise the granted share options in two periods. The second exercise period commences on the first trading day after expiry of the 24-month period from the date of grant and ends on the last trading day of the 36-month period from the date of grant. Accordingly, the second exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme will be the dates on which the share options are exercisable during the period from 25 September 2023 to 22 September 2024. Following the above adjustment, the number of participants entitled to exercise the share options during the second exercise period will be 397 and the number of exercisable share options will be 2,402,000.

#### **(II) Exercise conditions for the second exercise period have been fulfilled**

1. Exercise conditions for the second exercise period in relation to the Company's business performance: The total net profit attributable to holders of ordinary shares of the listed company for 2020, 2021 and 2022 not lower than RMB 10.23 billion.

According to the audited 2020, 2021 and 2022 financial reports of the Company considered and passed at the 2020, 2021 and 2022 Annual General Meeting of the Company, respectively, the net profits for 2020, 2021 and 2022 were RMB 4.26 billion, RMB 6.81 billion and RMB 8.08 billion, respectively. The exercise condition for the second exercise period of "the total net profit for 2020, 2021 and 2022 not lower than RMB 10.23 billion" has been fulfilled.

2. Events described in Paragraph 1 under Article 20<sup>①</sup> of the 2020 Share Option Incentive Scheme (Draft) have not happened to the Company during the valid period of the 2020 Share Option Incentive Scheme prior to the commencement of the second exercise period.

3. Events described in Paragraph 2 under Article 20 of the 2020 Share Option Incentive Scheme (Draft) have not happened to the participants during the valid period of the 2020 Share Option Incentive Scheme prior to the commencement of the second exercise period. The participants entitled to exercise have passed the performance appraisal in 2022.

Based on the above, the exercise conditions for the second exercise period of the reserved grant of share options under 2020 Share Option Incentive Scheme of the Company have been fulfilled.

### **(III) How non-fulfilled share options will be dealt with**

In accordance with the Draft Scheme, share options not qualified to be exercised or share options not exercised after the conclusion of the exercise period will lapse and will be withdrawn and cancelled by the Company without compensation.

### **(IV) Arrangements for exercise**

#### **1. Source of underlying shares: additional ordinary A Shares denominated in RMB placed to participants by the Company**

#### **3. Exercise price**

Pursuant to the Draft Scheme, the exercise price for the reserved grant of share options under the 2020 Share Option Incentive Scheme is RMB 34.92 per share.

#### **4. Exercise period**

The second exercise period for the reserved grant of share options under the 2020 Share Option Incentive Scheme shall be the dates on which the share options are exercisable during the period from

1. None of the following has occurred to the Company

(1) A certified public accountant furnishing an audit report containing an opinion of disapproval or indicating the inability to give an opinion in respect of the financial accounting report for the most recent accounting year;

(2) A certified public accountant furnishing an audit report containing an opinion of disapproval or indicating the inability to give an opinion in respect of the internal control of financial reporting for the most recent accounting year;

(3) Failure to conduct profit distribution in accordance with laws and regulations, the Articles of Association and public undertakings during the past 36 months after listing;

Participants shall not exercise their share options during the following periods in accordance with the Draft Scheme and “Shenzhen Stock Exchange Self-Disciplinary and Regulatory Guide for Listed Companies No. 10 — Management of Shareholding Changes”:

(1) The period commencing on the date which is 30 days prior to the publication of annual report and interim report, or in the event of delaying the announcement date for special reasons, 30 days prior to the original date of publication;

(2) The period commencing on the date which is 10 days prior to the quarterly report, preliminary results announcement or express results announcement of the Company;

(3) The period commencing on the date on which a significant event that may have a material impact on the trading prices of the Company’s shares and their derivative products or the date on which the decision-making relating to such significant event has started and ending on the day after the relevant announcement in accordance with the law; and

(4) Other periods stipulated by the CSRC and Shenzhen Stock Exchange.

“A significant event that may have a material impact” described above shall be transactions or other significant events required to be disclosed by the Company under the Rules Governing the Listing of Stocks on the Shenzhen Stock Exchange or Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

**5. The participants of the reserved share option granted under 2020 Share Option Incentive Scheme are all key employees of the Company. The Company’s Directors and senior management are not the participants of the reserved grant of share options.**

**6. The participants shall exercise the share options on a voluntary basis** and shall complete custodian registration procedures with China Securities Depository and Clearing Corporation Limited, Shenzhen Branch.

**7. Management of proceeds from the exercise of share options and arrangements for the payment of personal income tax**

Proceeds received from the exercise of share options shall be placed in a designated account of the Company. Participants shall not be required to pay any consideration to the Company on application or acceptance of the share options. Funds required for the exercise of options shall be paid on the date on which the participants exercise the share options and it shall be financed by the participants on their own. The Company undertakes not to provide any loans or financial assistance in any other forms to the participants for their exercise of share options under the 2020 Share Option Incentive Scheme, including the provision of guarantee for loans. Gains generated by the participants shall be subject to personal income tax and other tax charges in accordance with national laws and regulations on taxation.

**8. The exercise of share options will not result in the distribution of shareholdings not meeting listing requirements**

The 2,402,000 currently exercisable share options account for 0.05% of the total 4,783,247,052 shares of the Company. The total share capital of the Company will increase to 4,785,649,052, considering the full exercise of share options exercisable in the second exercise period, which will not result in non-compliance with listing requirements regarding the breakdown of shareholdings.

#### **(V) The effect of the exercise on the financial conditions and results of operation of the Company for the relevant year**

In accordance with the “ASBE 11 – Share-based Payment”, services rendered by participants are charged to relevant costs or expenses at the fair value of the share options on the date of grant and the capital reserve is credited accordingly, based on the best estimates of number of exercisable share options. During the exercise period of the share options, the Company will not adjust recognised costs or expenses. According to the actual situation of exercising, the Company recognized monetary funds received, as well as the increase in the share capital and capital reserve. If the share options for the second exercise period are exercised in full, the total share capital of the Company will increase by 2,402,000 shares, and its capital reserve will increase by RMB 81,475,840. The actual figures of the effect are subject to figures audited by the accountant.

#### **IV. Opinions of the Remuneration and Evaluation Committee**

1. The adjustment is in compliance with relevant provisions of “Administrative Measures on Share Incentives of Listed Company” (《上市公司股權激勵管理辦法》) and the Draft Scheme.
2. The cancellation of certain share options is in compliance with relevant provisions of pertinent laws and regulations and the Draft Scheme, and has conducted according to currently required procedures.
3. The exercise conditions have been fulfilled. The qualification of the participants of exercisable share options is legal and effective. The relevant arrangements for exercise for the second exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company are in compliance with relevant provisions of pertinent laws and regulations.

#### **V. Examination opinions of the Supervisory Committee**

1. The adjustment is in compliance with relevant provisions of “Administrative Measures on Share Incentives of Listed Company” and the Draft Scheme.
2. The cancellation of certain share options is in compliance with relevant provisions of pertinent laws and regulations and the Draft Scheme, and has conducted according to currently required procedures. It is approved that the Company shall handle matters related to the cancellation of share options in accordance with relevant provisions.
3. The exercise conditions have been fulfilled. The qualification of the participants of exercisable share options is legal and effective. The relevant arrangements for exercise for the second exercise period of the reserved grant of share options under the 2020 Share Option Incentive Scheme of the Company are in compliance with relevant provisions of pertinent laws and regulations.

#### **VI. Conclusion of the legal opinion**

Beijing Jun He Law Offices (Shenzhen Office) is of the view that:

1. The adjustment, cancellation and exercise of share options have been duly authorized and approved and conducted according to currently required procedures.
2. The exercise conditions of the current share options have been fulfilled.
3. The participants and number of share options of the Company, as adjusted by the Board of Directors of the Company pursuant to the mandate of general meeting of the Company and relevant provisions of the Draft Scheme, are in compliance with relevant provisions of pertinent laws and regulations, the Draft Scheme and the Articles of Association of ZTE Corporation.

4. The cancellation is in compliance with relevant provisions of the Draft Scheme and the Articles of Association of ZTE Corporation.

5. The Company shall process the cancellation of previously granted share options and fulfill its information disclosure obligations.
