Pursuant to the phase I share incentive scheme approved at the extraordinary general meeting of the Company on 13 March 2007, the rights to request the Company to issue a total of 47.98 million A shares (“Subject Shares”) have been granted to the scheme participants. Such rights shall be valid for a term of 5 years, comprising a lock-up period of the first 2 years and an unlocking period of the remaining 3 years. During the unlocking period, the scheme participants may apply for the subject shares being unlocked Subject Shares in 3 tranches subject to the unlocking conditions stipulated under the share incentive scheme being satisfied: In the first year of the unlocking period, the number of A shares unlocked and issued pursuant to the scheme shall not exceed 20% of the aggregate number of the Subject Shares. In the second year of the unlocked period, the number of the A shares unlocked and issued pursuant to the scheme shall not exceed 35% of the aggregate number of the Subject Shares. In the third year during the unlocked period, the number of the A shares unlocked and issued pursuant to the scheme shall represent all outstanding Subject Shares. If the unlocking conditions are not satisfied in any one year during the unlocking period, no application made by scheme participants during the such years, nor in subsequent years for unlocking of such Subject Shares will be accepted.
