Details of Movements in Issued Share Capital - Share Options (under Share Option Schemes of the Issuer)", (1) The first exercise period for the share options granted under the 2017 A Share Option Incentive Scheme of the Company covers the exercisable dates from 16 July 2019 to 5 July 2020 and the number of exercisable share options is 39,664,153. As at 30 April 2020, 38,581,931 share options for the first exercise period had been exercised, and 1,082,222 share options were outstanding; (2) 70,210,561 share options had been cancelled, as certain original participants no longer fulfilled the conditions to be a participant under the 2017 A Share Option Incentive Scheme, certain participants did not fulfill the exercise conditions for the first exercise period and the exercise conditions for the second exercise period were not fulfilled; (3) the Company had yet to determine whether the 39,726,486 share options under the third exercise period would be exercisable based on whether the Company and the participants had fulfilled the exercise conditions.

A total of 40,808,708 new shares of issuer which may be issued pursuant thereto as at close of the month, including 1,082,222 exercisable share options outstanding for the first exercise period and 39,726,486 share options relating to the third exercise period pending determination of whether the exercise conditions will be fulfilled by the Company and the participants.
